

1.0 INTRODUCTION

From March 31, 2022, through April 26, 2022, the Arizona Department of Transportation (ADOT) hosted a series of public meetings to introduce the public to the Interstate 17 (I-17) Improvement Project between Anthem Way and Sunset Point. The series included a virtual public meeting on Thursday, March 31, 2022, an online open house that was live from March 31,

2022, through April 26, 2022, and an in-person public meeting on April 26, 2022. The Kiewit-Fann Joint Venture (KFJV) assisted ADOT with this effort.

1.1 Project Overview

The 23-mile section of I-17 between Anthem Way and Sunset Point is one of the most heavily utilized roadways in Arizona, seeing more than 1 million travelers each year. The corridor is important for commerce and tourism, connecting southern Arizona to northern Arizona. It connects the major east-west corridors of I-10 and I-40, facilitating the movement of people and goods, and supporting the state's economic development and tourism.

ADOT has identified I-17 as a Key Commerce Corridor. Key Commerce Corridors connect the major economic centers of Arizona with their major markets. As such, these inter-regional routes are the most essential for future, quality economic growth in Arizona and support high-quality job growth. Efficient movement of people, supplies and goods supports growth and expansion of base industries and the state's overall economy.

Currently, I-17 has two travel lanes in each direction between Anthem Way, north of Phoenix, and Flagstaff. The highway passes through rolling and mountainous terrain, with steep, narrow lanes between Black Canyon City and Sunset Point.



Improving the stretch of I-17 between Anthem Way and Sunset Point includes widening 15 miles of roadway, replacing two bridges and widening 10 others, and constructing approximately 8 miles of flex lanes. The project is located within ADOT's Central and Northwest Districts in Maricopa and Yavapai counties, respectively.

1.2 Report Purpose

This report documents the public meeting series that took place in March and April of 2022 and steps that were taken by the project team to publicize and prepare for these events. The meetings were intended to support the following goals:

- Increase stakeholder understanding of the project.
- Provide opportunities for early and continuous engagement with stakeholders.
- Maintain accountability, credibility and accessibility of ADOT and the project team.
- Maximize potential for informed media.

Through the series of meetings, the team accomplished the following:

- Introduced stakeholders to the project.
- Described anticipated phasing to the extent possible and shared information about planned restrictions and closures.
- Discussed methods that will be used to communicate traffic impacts, lane and/or ramp closures and other planned construction activities.
- Promoted the project website.
- Answered questions about design and construction elements of the project.
- Provided project resources.

Additional special outreach efforts were implemented to ensure compliance with Title VI of the Civil Rights Act, the Americans with Disabilities Act (ADA), and Environmental Justice and Limited English Proficiency (LEP) guidelines where such populations were identified in the project area, and provided equitable opportunities to participate in all of the meetings.

1.3 Date, Time, Location and Overview of Meeting Series

1.3.1 Virtual Public Meeting

A virtual public meeting was held online on March 31, 2022, on the WebEx virtual platform. Participants had the option to join the meeting online or via telephone.

The meeting began at 6 p.m. Meeting participants viewed and/or listened to the ADOT Project Manager and ADOT Communications Project Manager as they explained the primary elements of the project. Upon completion of the presentation, a moderator provided instructions and support for a live question-and-answer session. Participants were able to make their comments or ask their questions verbally or type them into to the Question and Answer (Q&A) dialogue box provided as a feature of the virtual platform.


The primary emphases of the presentation were to provide a basic overview of the project and review of the current schedule, along with a description of work in progress in preparation for construction, and to ensure that everyone understood how to find project resources, including where to direct future questions and comments prior to and during construction.

1.3.2 Online Open House

Launched on March 31, 2022 at www.improvingi17.com, the online open house provided an opportunity for people to view a prerecorded version of the presentation that was delivered during the virtual public meeting. People could view the presentation, as well as the materials that were available during the virtual and in-person meetings, at any time at their own pace through April 26, 2022, and provide comments via the website.

1.3.3 In-Person Public Meeting

An in-person public meeting was held on April 26, 2022, from 5:30 to 7:30 p.m., at Canon Elementary School, located at 34630 School Loop Road in Black Canyon City. Participants were invited to sign in upon arrival and peruse a variety of displays and interact with Project Team members in open-house fashion until the presentation started at 6 p.m. The meeting layout is pictured below:



Displays addressed topics related to the project, including a general timeline, construction activities, the concept of flex lanes, traffic restrictions, environmental considerations and noise barriers. The largest exhibits were printed roll plots that provided an aerial view of the entire

project, with features and activities labeled (e.g., areas of controlled rock blasting, areas of widening, and earthwork statistics such as excavation and embankment quantities).

The formal presentation was delivered by the ADOT Communications Project Manager and the ADOT Deputy Project Manager using prepared remarks and slides to explain the project's necessity, geographical challenges, anticipated impacts during construction and benefits when work is complete. Members of the project team discussed the location and performance of flex lanes and related signage, monitors and vehicle-arresting barriers; this was a topic of special interest, as this is the first project in Arizona to utilize a flex-lane system.

Following the scripted remarks, subject matter experts and key members of the project team fielded 18 questions from the audience. Project team members remained available to speak with attendees one-on-one and answer their questions after the presentation. Opportunities for attendees to share written comments were also provided via paper and pen, or at an online comment station via tablets programmed to the "Let's Connect!" page on improvingi17.com. At the exit, attendees were offered a magnet containing a QR code leading to the project website, the web address written out, and a telephone number to use for questions, comments or concerns throughout the project's span.

2.0 NONDISCRIMINATION

The public meeting series was planned, promoted and conducted in compliance with the ADOT Public Involvement Plan and the federal nondiscrimination mandates detailed below.

2.1 Title VI of the Civil Rights Act of 1964

Title VI of the Civil Rights Act of 1964 and related statutes ensure that individuals are not excluded from participation in, denied the benefit of or subjected to discrimination on the basis of race, color, national origin, sex or disability. The implementation of the meeting series plan ensured that protected populations received information about the I-17 Improvement Project and three types of public-participation opportunities, and were encouraged to participate in the public meetings.

The following efforts were made to ensure that the meeting was conducted in compliance with Title VI of the Civil Rights Act:

- Using ADOT's Standard Nondiscrimination Language in English and Spanish on all
 public-facing materials that invited members of the public to participate in any type of
 ADOT event, meeting, survey, or other opportunity to provide information.
- Sharing, with permission, information at community meeting places.

- Using a virtual platform with inclusive features such as real-time translation in Spanish and closed captioning in English and Spanish.
- Having a Spanish interpreter attend the in-person meeting.
- Ensuring that a representative from the ADOT Civil Rights Office attended the in-person meeting and provided written information in English and Spanish about each meeting participants' rights under Title VI.
- Sharing information in English and Spanish about meeting participants' rights under Title VI verbally and on slides during the virtual public meeting.

2.2 Americans with Disabilities Act of 1990

The ADA stipulates that people with disabilities are involved in developing and improving public services. In highway planning, collaboration with persons with disabilities is essential for developing access points beyond what is required. All events held for federally funded programs or projects that are open to the public must be made accessible to everyone, including persons with disabilities.

The following efforts were made to ensure that persons with disabilities had access to project information:

- Conducting a virtual public meeting and providing an online open hosue to make meeting and project information accessible to people unable to attend an in-person meeting because of a physical disability or illness.
- Including instructions for requesting an accommodation for a disability during the virtual public meeting.
- Using ADOT's Standard Nondiscrimination Language in English and Spanish on advertisements and mailers.
- Providing live closed captioning in English and Spanish during the virtual public meeting.
- Ensuring that the location of the in-person public meeting was accessible to persons with physical disabilities.

There were no requests for any accommodations because of a disability.

2.3 Environmental Justice

In 1994, Executive Order (EO) 12898, Federal Actions to Address Environmental Justice in Minority Populations and Low-Income Populations, was issued. Environmental Justice "is the fair treatment and meaningful involvement of all people, particularly minority, low-income and Indigenous populations, in the project."

To engage traditionally underserved communities, the project team made the following community engagement efforts:

- Offering a virtual public meeting and online open house to promote participation by those who might otherwise be able to attend because of circumstances such as work schedule, need for childcare, or other limitations.
- Using ADOT's Standard Nondiscrimination Language on all public-facing materials that invited members of the public to participate in any type of ADOT event, meeting, survey, or other opportunity to provide information.
- Sharing, with permission, meeting information at community meeting places.

2.4 Limited English Proficiency

The term Limited English Proficiency (LEP) is used to describe individuals who are not proficient in the English language. ADOT provided materials in English and Spanish. There were no requests for information in other languages. ADOT made the following community engagement efforts to engage LEP persons:


- Providing all public-facing materials that invited members of the public to participate in any type of ADOT event, meeting, survey, or other opportunity in Spanish.
- Providing meeting materials in English and Spanish.
- Using plain language and clear graphics to convey project information.
- Including clear instructions to log on or call into the meeting.
- Explaining how the meeting would be conducted.
- Encouraging the public to contact the project team for questions, comments and assessment of project materials using the project information line, project email, project website or United States Postal Service (USPS) mail.
- Providing Spanish translators.
- Allowing the online open house to be available in multiple languages utilizing the page translation tool.

3.0 MEETING NOTIFICATIONS

ADOT adopted an integrated and multifaceted outreach strategy to communicate information to stakeholders about the public meeting series. This included direct mail, newspaper and digital advertising, canvassing, email notifications, social media postings and press releases. Stakeholders received messages about the public meeting series starting one week prior to the first event (virtual public meeting) and again prior to the in-person meeting.

3.1 Direct Mail

ADOT mailed 12,426 bilingual postcards on March 23, 2022, using Every Door Direct Mail (EDDM), a service offered by the USPS that includes an online tool enabling delivery to specified areas.



EDDM pieces are bundled for delivery, lowering the cost per piece compared to first class mail. Appendix A provides documentation of the delivery areas, which included the following ZIP codes and quantities:

- 85087 (3,063)
- 86333 (3,158)
- 85086 (6,205)

The postcard publicized the entire public meeting series, including the virtual public meeting, online open house and in-person public meeting.

3.2 Newspaper Advertisements

ADOT prepared and placed bilingual print advertisements prior to the in-person public meeting. The ads provided an overview of the project, information on how to access and receive project information and an invitation to attend the meeting. The ads also included information about the online open house. Details of the newspaper ads are summarized below and copies are included in Appendix B.


3.3 Digital Advertisements

Digital advertisements in English and Spanish also ran on online platforms hosted by various news outlets. In addition to the print ads described above, ADOT placed digital advertisements at the following outlets during the listed timeframes:

- Anthem Independent: March 17-31, 2022, and April 13-26, 2022
- Prescott Daily Courier: March 17-31, 2022, and April 12-26, 2022
- La Voz (Spanish): March 18-31, 2022, and April 12-26, 2022

Examples of the ads are included below. The March ads publicized the virtual public meeting and the April ads publicized the in-person public meeting. The successful reach of the digital ads can be expressed in terms of "impressions," which are trackable events that occur any time a user opens an app or website and an advertisement is visible. Total impressions for the digital advertising campaign were 215,000, as detailed below:

- La Voz 145,000 impressions









3.4 Canvassing

4.0 MEETING PREPARATION

The project communications team has a standing virtual meeting once a week, usually on Monday. In addition, specifically to plan the virtual public meeting, the project communications team met virtually on March 10, 2022, and in-person twice on March 29, 2022. On March 10, topics included logistics pertaining to the room where the virtual meeting would be led and recorded, a high-level design overview, construction phasing, methods of publicizing the virtual meeting, developing a Frequently Asked Questions (FAQ) reference document, and identifying personnel and subject-matter experts. On the morning of March 29, a working script and slideshow was critiqued by the communications team and refined for a run of show in the afternoon. The dress rehearsal took place in the room and with the technology that would be

used during the virtual public meeting. Additional revisions were made to the script, slides and FAQs on March 30-31, 2022.

The communications team met on April 20, 2022, to plan the in-person meeting. During this planning meeting, roll plots for the project were critiqued and annotated for revision, public meeting etiquette was reviewed, and material supplies and personnel attendance were confirmed.

Appendix F details the Run of Show for the in-person public meeting, including team roles, session details, the session timeline, a link to presentation and accompanying script, and instructions that were given to participants. Appendix G contains the meeting presentation.

5.0 PARTICIPATION AND COMMENTS

5.1 Virtual Public Meeting

A total of 270 individuals logged in to the virtual meeting using the desktop application, mobile application, web application or phone. Spanish-speaking attendees were able to call in to the Spanish-language audio channel and connect to the English video to see the presentation. A Spanish translator called into the meeting and interpreted presenters in real time. Eighty-four Spanish-language speakers participated in the meeting. During the Q&A portion of the meeting, the following questions were discussed:

- Why the KFJV was created.
- Whether manufactured homes and loads of 18 feet wide would be able to use I-17 during construction.
- How the flex lanes would be used Monday through Thursday.
- The plans for "outside lanes."
- Whether large, slow loads would be permitted to use the flex lanes.
- Backup systems for flex lane operations in case of power failure.
- Whether blasting activities would require full northbound closures, and if so, how much notice would be provided.
- How the project is funded.
- Whether ADOT's permitting process for wide loads would be affected during construction.
- Strategies to avoid triggering wildfires during construction.
- Whether posted speed reductions would have to be followed if no active work is evident.
- Whose responsibility landscape maintenance would be after construction is complete.
- Whether frontage road traffic would be affected where a Great Hearts Academy is under construction.

- Whether enforcement of reduced speed limits in construction zones can become more robust.
- Whether nighttime construction noise would reach area residences.
- The expected lifespan of the project in terms of efficiently serving a growing population.
- Whether motorists would be able to access the flex lanes when entering northbound I-17 at Milepost 244.
- The source of water for the project.
- Whether hazardous cargo would be prohibited in the flex lanes.
- How speed limits may be increased/decreased.
- Whether construction will start this year.
- Whether northbound trucks would be restricted to the right lane.
- Whether additional federal funding is being sought for the project.
- The speed limit in the flex lanes when completed.
- The expected duration of construction.
- Whether other Arizona interstates are planning to adopt flex lanes.
- Whether a bottleneck is to be expected where flex lanes merge.
- Whether northbound and southbound speed limits would differ.
- When to expect to see the first lane closures due to construction.
- Whether the project would reduce northbound congestion at the start of each weekend.
- Whether the flex lanes would be concrete or asphalt.
- The accident rate statistics of existing flex lane systems.
- Whether frontage roads would be used to bypass construction between Anthem Way and New River Road.

5.2 Online Open House

The online open house had 2,306 views while it was live between March 31 and April 26, 2022. It was available in multiple languages by using the page translation tool. The team did not receive any questions or comments via the online open house.

5.3 In-Person Public Meeting

A total of 73 individuals or households voluntarily signed in at the entrance to the meeting, and all legible information (including 33 email addresses) was later entered into a stakeholder database specific to the I-17 project. A Spanish translator was introduced at the start of the prepared remarks; no attendees requested live interpretation.



During the Q&A portion of the meeting, the following matters were discussed:

- Maintenance responsibilities.
- How the project is funded.
- The plan if the project exceeds budget.
- The locations and timing of potential rock crushing noise.
- Noise-barrier wall locations.
- The source of water for the project: aquifers, Cordes Lakes water.
- Parameters of the project originally versus present day.
- How to protect people in towns along I-17 from drivers who disregard stop signs.
- How to report traffic violators.
- Whether accident rates dictated the parameters of the project.
- The reason that flex lanes are not designed to merge between Milepost 242 and 243.
- Whether trailers would be permitted in the flex lanes.

One written comment sheet was completed during the meeting, and addressed the following matters:

- The merging location between Anthem and Black Canyon City.
- Whether slower traffic can be prohibited from the flex lanes.
- How ADOT will control a higher volume of traffic using Black Canyon City streets.
- The non-four-way stop at the end of southbound Exit 244.
- Whether any Black Canyon City streets will be used for construction staging and then repaired or repaved.
- The height of the noise-barrier wall near Agua Fria southbound, and whether any walls are planned northbound through Black Canyon City.
- Whether flex lanes can be accessed when entering I-17 at Coldwater Canyon Road (Milepost 244).
- The choice to install flex lanes versus adding a single commuter lane in each direction.

Six attendees signed up for project updates, and three attendees submitted comments using tablets provided at the online comment station in the meeting room. Their comments, verbatim, are as follows:



- We would like a full print out of the map which pertains to Black Canyon City. The 8-foot one that you had on the table tonight. We will put it up in the museum.
- As Chair of the Upper Agua Fria Watershed Partnership, I'd like to express our group's concern about the source of water for this project. The 2010 to 2013 Cordes Junction traffic interchange reconfiguration water use caused the drying of a spring on Big Bug

Creek as well as other aquifer impacts. We believe that the 1.5 billion gallons of water necessary for this project should not impact either current water users or the environment.

• Concerned about a sound barrier on the east side between 242 and the overpass at Mud Springs. Already very noisy with all of the traffic that we currently have on a very busy freeway. Also concerned about the amount of water that will come out of our aquifers and well systems! Thank you for coming to do a presentation on what will be happening.

The 23 miles of improvements include 15 miles of roadway widening from Anthem Way to Black Canyon City, two bridge replacements, one bridge deck replacement, 10 bridge widenings, and the installation of an approximately eight-mile flex lane system from Black Canyon City to Sunset Point. Flex lanes are a new feature for Arizona's

highway system and are proven technology to help reduce congestion on I-17 during peak travel times and allow for traffic movement during emergency situations.

The I-17 flex lanes will operate as a separate, two-lane roadway carrying one direction of traffic at a time depending on the greatest need along the steep, winding 8 miles between Black Canyon City and Sunset Point. For example, the flex lanes will be able to carry heavy northbound traffic on a Friday or heavy southbound traffic on a Sunday. Similarly, ADOT will be able to open the flex lanes to accommodate traffic any time if a crash or other incident causes long delays. The flex lanes will be next to, but physically separated from southbound I-17 using concrete barriers. Access to the flex-lane entrances will be controlled by gates.

The project's virtual open house can be accessed via improvingi17.com/openhouse and has been live since March 31. This standing open house provides the same information as the March 31 virtual public meeting and the in-person meeting on April 26, but can be viewed at your convenience. It also provides opportunities to ask questions or submit comments. This option will be available through April 26. To date, more than 1,200 people have utilized the online open house.

Construction on the highly anticipated I-17 Improvement Project: Anthem Way to Sunset Point will begin later this year and is expected to take approximately three years to complete. Pre-construction work is currently underway. Once the major work officially begins, drivers can expect the entire 23 miles to be under construction at once and should plan their trips accordingly.

Once complete, this project will help alleviate congestion and improve safety and traffic flow north of the metro-Phoenix region. The 23 miles of improvements include 15 miles of roadway widening from Anthem Way to Black Canyon City, two bridge replacements, one bridge deck replacement, 10 bridge widenings, and the installation of an approximately eight-mile flex lane system from Black Canyon City to Sunset Point. Flex lanes are a new feature for Arizona's highway system and are proven technology to help reduce congestion on I-17 during peak travel times and allow for traffic movement during emergency situations.

The I-17 flex lanes will operate as a separate, two-lane roadway carrying one direction of traffic at a time depending on the greatest need along the steep, winding 8 miles between Black Canyon City and Sunset Point. For example, the flex lanes will be able to carry heavy northbound traffic on a Friday or heavy southbound traffic on a Sunday. Similarly, ADOT will be able to open the flex lanes to accommodate traffic any time if a crash or other incident causes long delays. The flex lanes will be next to, but physically separated from southbound I-17 using concrete barriers. Access to the flex-lane entrances will be controlled by gates.

Una vez completado, este proyecto ayudará a aliviar la congestión y mejorará la seguridad y el flujo de tráfico al norte de la región metropolitana de Phoenix. Las 23 millas de mejoras incluyen 15 millas de ampliación de carreteras desde Anthem Way hasta Black Canyon City, el reemplazo de dos puentes, el reemplazo de la cubierta de un puente, la ampliación de 10 puentes y la instalación de un sistema de carriles flexibles de aproximadamente ocho millas desde Black Canyon City hasta Sunset Point.



11. **Project Overview**

The 23-mile section of Interstate 17 (I-17) between Anthem Way and Sunset Point is one of the most heavily utilized roadways in Arizona, seeing more than 1 million travelers each year.

We look forward to improving this stretch of I-17 north of Phoenix. The work includes widening 15 miles of roadway, constructing approximately eight miles of flex lanes, replacing two bridges, replacing one bridge deck, and widening 10 other bridges.

This project is divided into two segments:

Anthem Way to Black Canyon City (Widening) Improvements:





- An additional northbound and southbound lane.
- Northbound widening on the median side.
- Southbound widening on the median side in some sections and widening on the outside in other sections.

Black Canyon City to Sunset Point (Flex Lanes) Improvements:

- Construct two flexible travel (flex) lanes alongside the existing southbound lanes of I-17. The flex lanes will be separated from the southbound roadway by a concrete barrier.
- Flex lanes will be open to northbound or southbound traffic, depending on the peak traffic direction and the greatest need.

12. **Project Benefits**

Annette R.

This project will increase capacity in both the northbound and southbound directions, helping to alleviate traffic congestion during weekends and holidays.

Additionally, the creation of the flex lanes will allow peak traffic to flow more efficiently. The increased capacity and improved traffic flow will help to improve safety for everyone on the road.



13. Project Team

The I-17 Improvement Project is being delivered using a method called "Design-Build-Operate-Maintain", which means that design and construction services, as well as a period of operation and maintenance, are contracted by a single entity. This is different from the





traditional approach for construction projects, known as design-bid-build, where engineers complete the design and then a contractor is hired to build what has been designed.

The design—build method changes the traditional sequence of work and allows the construction team to be involved in design. The time it takes to complete the project is reduced by overlapping the design phase and construction phase of a project.

Kiewit-Fann Joint Venture, or KFJV, has been selected as the developer team for the Project.


14. **Project** Timeline

Since the design concept report was finalized in 2019, ADOT began the procurement process to select a developer team that will be responsible for final design, construction, and operations and maintenance of the project.

ADOT signed an agreement with KFJV in late 2021.

Final design and construction activities have begun, with segments of the project opening in late 2024 and 2025.



15. Cross Section 1

Annette R.

As previously stated, the 23-mile project will include widening and a flex lane system. Due to the terrain and right-of-way throughout the corridor, new lanes may be located on the inside or outside of the roadway.

The following graphics illustrate the additional lanes that will be added to the interstate.

From Anthem Way to just north of Moore's Gulch (depicted on the map to the left), crews





	will construct one additional lane in both directions within the existing median between the two roadways.

Two additional lanes will be constructed adjacent to the existing southbound lanes. They will be open to northbound or southbound traffic, depending on peak travel times or the greatest need.

Widening the highway in both directions between Black Canyon City and Sunset Point was studied, however several factors contributed to the decision to deem it an unfeasible alternative during the environmental study:

- Much of the northbound stretch of I-17 from Black Canyon City to Sunset Point is in an extremely mountainous area. This difficult terrain would require extensive modifications to the existing roadway to meet current design standards, beyond simply just widening the lanes and adding additional shoulder area.
- Causing minimal disruptions to this highly traveled corridor was another major factor when considering alternatives. Widening the existing roadway would cause an extreme disruption to traffic over a prolonged period of time with no viable alternative route available.
- To widen the lanes, complete closures of at least one and possibly both lanes in both directions would be needed to complete earthwork operations, including blasting and mitigation of rock fall hazards.
- These factors would cause extreme traffic interruptions and the cost would be prohibitive.



20. Flex Lanes Access

Annette R.

The flex lanes will be equipped with an electronic gate system and net barriers that slow and stop vehicles from entering the roadway in the wrong direction.

In addition, there will be overhead signs alerting drivers to which direction is in use.

The entire system will be monitored and controlled by ADOT's Traffic Operations Center.



21. Flex Lanes Operations


Typically, the flex lanes will be:

- Open to northbound traffic Monday through Saturday
- Open to southbound traffic on Sundays

ADOT will adjust the direction of the flex lane as needed to accommodate holiday travel and unexpected congestion due to an incident.

Should an **incident occur** within the flex lanes, traffic can be diverted back to the southbound lanes.

- There are four locations where barrier gates will be installed in the barrier between the flex lanes and the existing southbound general purpose lanes.
- These barrier gates will allow emergency vehicles to open the gates and clear traffic out of the flex lanes and into the southbound general purpose lanes.

22. Preconstruction nactivities

This project officially started in November 2021. Although construction will not begin until later this year, ADOT and KFJV are coordinating daily to prepare for construction along this critical section of interstate.


As you might imagine, there is a lot of work that needs to happen before construction can begin; for example, the team needs to develop and complete numerous written documents, such as a baseline schedule for the next three years of work, a traffic management plan, emergency action plans, and other critical documents. Then, all of those documents must be reviewed and approved.

Throughout the past few months, drivers may have seen some work along the shoulders or even experienced lane restrictions on I-17 between Anthem Way and Sunset Point. This has been for geotechnical investigations – where large drilling equipment take samples of the ground in various locations to determine soil conditions and assist with the design of bridge widenings and other project elements.

The team also has been working on surveys to identify migratory bird patterns and develop mitigation strategies to prevent conflicts during nesting season. There are months of work that go into a huge design-build project like this before the major construction starts.

Another activity that will take place prior to major construction will be plant salvage, which is the process of relocating viable native species of plants to a temporary nursery and then replacing them after construction.







primarily be limited to weeknights from 7 p.m. to 6 a.m. However, travelers should remain cautious in the construction zone, which will be active seven days a week.

No weekend or weekday lane closures will be scheduled for construction, which allows you to use I-17 during peak travel days and times with limited construction impacts or restrictions. (A closure might occur on a weekend due to an emergency or unplanned incident.)

Construction is not anticipated to impact weekend, weekday or holiday travel. The construction work will be done primarily during the weekdays, with lane closures scheduled on weeknights, Sunday through Thursday on the northbound side and Monday through Thursday on the southbound side.

The 23-mile section of Interstate 17 (I-17) between Anthem Way and Sunset Point is one of the most heavily utilized roadways in Arizona, seeing more than 1 million travelers each year. This corridor serves heavy recreational traffic and as a key commerce corridor, heavy truck traffic as well.

Currently, this segment of I-17 has two lanes in each direction, for both Southbound and Northbound.


This project work we are going to construct can be divided into two segments:

Anthem Way to Black Canyon City (Widening) Improvements:

• An additional northbound and southbound lane.

From Black Canyon City to Sunset Point (Flex Lanes) Improvements:

- Constructing two flexible travel (flex) lanes alongside the existing southbound lanes of I-17. The flex lanes will be separated from the southbound roadway by a concrete barrier.
- These lanes will be open to northbound or southbound traffic, depending on the peak traffic direction and the greatest need.



The addition of these lanes will increase capacity in both the northbound and southbound directions, helping to alleviate traffic congestion during weekends and holidays.


Installation of the flex lanes will allow peak traffic to flow more efficiently. The increased capacity and improved traffic flow will help to improve safety for everyone on the road while supporting economic growth within the region.



The I-17 Improvement Project is being delivered using a method called "Design-Build-Operate-Maintain", which means that design and construction services, as well as a period of operation and maintenance, are contracted by a single entity. This is different from the traditional approach for construction projects, known as design-bid-build, where engineers complete the design and then a contractor is hired to build what has been designed.

The design—build method allows us to design and construction at the same time reducing the overall duration to complete the entire segment.

Kiewit-Fann Joint Venture, or KFJV, has been selected as the Contractor team for the Project.



Since the design concept report was finalized in 2019, ADOT began the procurement process to select a developer team that will be responsible for final design, construction, and operations and maintenance of the project.


ADOT signed an agreement with KFJV in late 2021.

Final design and construction activities have begun, with segments of the project opening in late 2024 and 2025.




As previously stated, the 23-mile project will include widening and a flex lane system. Due to the terrain and right-of-way throughout the corridor, new lanes may be located on the inside or outside of the roadway.


This graphics illustrate the additional lanes that will be added to the interstate From Anthem Way to just north of Moore's Gulch (depicted on the map to the left). One additional lane in both directions will be constructed within the existing median between the two roadways.




From north of Moore's Gulch to just south of Rock Springs, the southbound lane will be constructed on the outside, while the northbound lane will be constructed in the median.



Through Black Canyon City, one lane will be added in each direction within the median.



Between Black Canyon City and Sunset Point, a flex lane system will be constructed. This will require significant earthwork activity to widen southbound I-17 to add two lanes, which will be separated from the existing roadway with a concrete barrier. Northbound I-17 will remain unchanged.




We understand there is a lot of curiosity and excitement regarding the 8-mile flex lane system that will be included in this project, so we would like to spend some time explaining why it was chosen for this stretch of interstate and how it will operate.

Flex lanes are a system that allows ADOT to vary the number of northbound or southbound lanes during peak travel times, or if there is a crash or another emergency situation that causes traffic delays.

Two additional lanes will be constructed adjacent to the existing southbound lanes. They will be open to northbound or southbound traffic, depending on peak travel times or the greatest need.

Widening the highway in both directions between Black Canyon City and Sunset Point was studied, however several factors contributed to the decision to deem it an unfeasible alternative during the environmental study:

- Much of the northbound stretch of I-17 from Black Canyon City to Sunset Point is in an
 extremely mountainous area. This difficult terrain would require extensive modifications to the
 existing roadway to meet current design standards, beyond simply just widening the lanes and
 adding additional shoulder area.
- Due to major earthwork activities associated with widening both sides of the lanes, complete
 closures of at least one and possibly both lanes in both directions would be needed to
 complete earthwork operations, including blasting and mitigation of rock fall hazards.
- These factors would cause extreme traffic interruptions and the cost would be prohibitive.



The flex lanes will be equipped with an electronic gate system and net barriers that slow and stop vehicles from entering the roadway in the wrong direction.

There will also be overhead signs alerting drivers to which direction the flex lanes are in use.

The entire system will be monitored and controlled by ADOT's Traffic Operations Center with cameras visually covering the entire length of the Flex Lanes.



NORMAL OPERATIONS

Open to northbound traffic Monday through Saturday.

Open to southbound traffic on Sunday.

HOLIDAY OPERATIONS

Open direction will be adjusted as needed to accommodate travel during holidays.

INCIDENT OPERATIONS

Open direction can switch based on unexpected congestion or an incident to alleviate backups.



Typically, the flex lanes will be:

- Open to northbound traffic Monday through Saturday
- Open to southbound traffic on Sundays

ADOT will adjust the direction of the flex lane as needed to accommodate holiday travel and unexpected congestion due to an incident.

Should an incident occur within the flex lanes, traffic can be diverted back to the southbound lanes.

- There are four locations where barrier gates will be installed in the barrier between the flex lanes and the existing southbound general purpose lanes.
- These barrier gates will allow emergency vehicles to open the gates and clear traffic out of the flex lanes and into the southbound general purpose lanes.



This project officially started in November 2021. Although construction will not begin until later this year, ADOT and KFJV are coordinating daily to prepare for construction along this critical section of interstate.

As you might imagine, there is a lot of work that needs to happen before construction can begin; for example, the team needs to develop and complete numerous written documents, such as a traffic management plan, emergency action plans, and other critical documents. Then, all of those documents must be reviewed and approved.

Throughout the past few months, you may have seen some work along the shoulders or even experienced lane restrictions on I-17 between Anthem Way and Sunset Point. This has been for geotechnical investigations — where large drilling equipment take samples of the ground in various locations to determine soil conditions and assist with the design of bridge widenings and other project elements.

The team also has been working on surveys to identify migratory bird patterns and prepare mitigation strategies to prevent conflicts during nesting season. There are months of work that go into a huge design-build project like this before the major construction starts.

Another activity that will take place prior to major construction will be plant salvage, which is the process of relocating viable native species of plants to a temporary nursery and then replacing them after construction.



Earthwork and Excavation

Balancing material throughout corridor.

Controlled Rock Blasting

Will require brief full closures for safety.

Bridge Widening/Replacements

Will require phased traffic control.

Used to widen roadways | emergency pullouts every two miles.

Construction is not anticipated to impact weekend or holiday travel.

ADOT anticipates construction will begin later this summer and take approximately three years to complete. This timeline makes it possible for the project team to minimize impacts on the traveling public while work is underway.

Because much of the travel and congestion on I-17 occurs on weekends, lane closures will primarily be limited to weeknights from 7 p.m. to 6 a.m. However, travelers should remain cautious in the construction zone, which will be active seven days a week.

No weekend or weekday lane closures will be scheduled for construction, which allows you to use I-17 during peak travel days and times with limited construction impacts or restrictions. (A closure might occur on a weekend due to an emergency or unplanned incident.)

Construction is not anticipated to impact weekend, weekday or holiday travel. The construction work will be done primarily during the weekdays, with lane closures scheduled on weeknights, Sunday through Thursday on the northbound side and Monday through Thursday on the southbound side.
